

Please follow the Procedures for RPV in the Administrative Guide for the  $3^{rd}$  AGM.

A shareholder who has appointed proxy or attorney or authorised representative to attend, participate, speak and vote at the 3<sup>rd</sup> AGM must request his/her proxy or attorney or authorised representative to register himself/herself for the RPV at TIIH Online website at https://tiih.online in accordance with the procedures set out in the Administrative Guide.
