## ADMINISTRATIVE GUIDE FOR EXTRAORDINARY GENERAL MEETING

• The Broadcast Venue of the Extraordinary General Meeting ("EGM") of the Company is strictly for the purpose of compliance with Section 327(2) of the Companies Act 2016. Shareholders/ proxy(ies) will not be allowed to attend the EGM in person at the Broadcast Venue on the day of the EGM of the Company. With the Remote Participation and Voting ("RPV") facilities, you may exercise your right as a member of the Company to participate (including the right to pose questions to the Board of Directors and/or Management of the Company) and vote at the EGM. Alternatively, you may also appoint the Chairman of the meeting as your proxy to attend and vote on your behalf at the EGM.

### **RPV FACILITIES**

- The RPV facilities are available on Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor")'s **TIIH Online** website at <a href="https://tiih.online">https://tiih.online</a>.
- Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the EGM using RPV facilities from Tricor.
- Kindly refer to Procedures for RPV as set out below for the requirements and procedures.

## PROCEDURES TO REMOTE PARTICIPATION AND VOTING VIA RPV FACILITIES

 Please read and follow the procedures below to engage in remote participation through live streaming and online remote voting at the EGM using the RPV facilities:

# Before the day of the EGM

i. Register as a user with TIIH Online	<ul> <li>Using your computer, access to website at <a href="https://tiih.online">https://tiih.online</a>. Register as a user under the "e-Services" select "Create Account by Individual Holder". Refer to the tutorial guide posted on the homepage for assistance.</li> <li>Registration as a user will be approved within one (1) working day and you will be notified via e-mail.</li> <li>If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.</li> </ul>

ii. Submit your request to attend EGM remotely	<ul> <li>Registration is open from Friday, 26 April 2024 at 3:00 p.m. until the day of the EGM on Monday, 13 May 2024 at 3:00 p.m. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the EGM to ascertain their eligibility to participate in the EGM using the RPV.</li> <li>Login with your user ID (i.e. e-mail address) and password and select the corporate event: (Registration) CENGILD MEDICAL BERHAD EGM 2024</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> </ul>	

Select "Register for Remote Participation and Voting".
Review your registration and proceed to register.
System will send an e-mail to notify that your registration for remote participation is received and will be verified.
After verification of your registration against the Record of Depositors as at 6 May 2024, the system will send you an e-mail after 6 May 2024 to approve or reject your registration for remote participation.

(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).

## On the EGM Day

i.	Login to TIIH Online	Login with your user ID and password for remote participation at the EG at any time from 2:00 p.m. i.e. 1 hour before the commencement meeting at 3:00 p.m. on Monday, 13 May 2024.		
ii.	Participate through Live Streaming	Select the corporate event:     (Live Stream Meeting) CENGILD MEDICAL BERHAD EGM 2024 to engage in the proceedings of the EGM remotely.  If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will try to respond to questions submitted by remote participants during the EGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.		
iii.	Online remote voting	<ul> <li>Voting session commences from 3:00 p.m. on Monday, 13 May 2024 until a time when the Chairman announces the end of the session.</li> <li>Select the corporate event: (Remote Voting) CENGILD MEDICAL BERHAD EGM 2024 or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>		
iv.	End of remote participation	Upon the announcement by the Chairman on the conclusion of the EGM, the Live Streaming will end.		

### Note to users of the RPV facilities:

- (i) Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

## **Entitlement to Participate and Appointment of Proxy**

- Only members whose names appear on the Record of Depositors as at 6 May 2024 shall be eligible to attend, speak and vote at the EGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the EGM will be conducted on a fully virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Proxy Form.
- If you wish to participate in the EGM yourself, please do not submit any Proxy Form for the EGM. You will not be allowed to participate in the EGM together with a proxy appointed by you.

 Accordingly, proxy forms and/or documents relating to the appointment of proxy/corporate representative/attorney for the EGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than Saturday, 11 May 2024 at 3:00 p.m.:

Proceed with submission of form of proxy	<ul> <li>After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password.</li> <li>Select the corporate event: CENGILD MEDICAL BERHAD EGM 2024 - "Submission of Proxy Form".</li> <li>Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>Insert your CDS account number and indicate the number of shares for your proxy(s) to vote on your behalf.</li> <li>Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide on your votes.</li> <li>Review and confirm your proxy(s) appointment.</li> <li>Print the form of proxy for your record.</li> </ul>

ii. Steps for corporation or institutional shareholders					
Register as a User with TIIH Online	<ul> <li>Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects "Create Account by Representative of Corporate Holder".</li> <li>Complete the registration form and upload the required documents.</li> <li>Registration will be verified, and you will be notified by email within one (1) to two (2) working days.</li> <li>Proceed to activate your account with the temporary password given in the email and re-set your own password.</li> <li>Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user</li> </ul>

submission of form of proxy	<ul> <li>Select the corporate exercise name: CENGILD MEDICAL BERHAD EGM 2024 - "Submission of Proxy Form".</li> <li>Agree to the Terms &amp; Conditions and Declaration.</li> <li>Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein.</li> </ul>				

•	Prepare the file for the appointment of proxies by inserting the
	required data.
•	Proceed to upload the duly completed proxy appointment file.
•	Select "Submit" to complete your submission.

Print the confirmation report of your submission for your record.

## **POLL VOTING**

- The voting at the EGM will be conducted by poll in accordance with Rule 8.31A of the ACE Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).
- Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from 3:00 p.m. on Monday, 13 May 2024 but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to "Procedures to Remote Participation and Voting via RPV Facilities" provided above for guidance on how to vote remotely via TIIH Online.
- Upon completion of the voting session for the EGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

### PRE-MEETING SUBMISSION OF QUESTIONS

The Board recognises that the EGM is a valuable opportunity for the Board to engage with shareholders. In order to enhance the efficiency of the proceedings of the EGM, shareholders may in advance, before the EGM, submit questions to the Board of Directors via Tricor's TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>, by selecting "e-Services" to login, post your questions and submit it electronically no later than Saturday, 11 May 2024. The Board of Directors will endeavor to address the questions received at the EGM.
