A. NOTES TO THE UNAUDITED INTERIM FINANCIAL REPORT FOR THE THIRD QUARTER ENDED 31 MARCH 2024

A1. Basis of preparation

The Group recorded revenue of RM50.71 million for the cumulative quarter ended 31 March 2024, representing a decrease of RM3.80 million or 6.97% as compared to the corresponding preceding cumulative quarter ended 31 March 2023 of RM54.51 million. The decrease in revenue was mainly due to lower patients volume, coupled with the decrease in number of endoscopic procedures and surgeries performed.

The Group's PBT decreased by RM1.56 million or 10.62% for the current cumulative quarter mainly due to the decline in revenue and professional fees from the proposed acquisition.

The increase in revenue was mainly due to higher patients volume, coupled with the increase in number of surgeries performed.
